Joining the *Quaker Studies Research Association*

Quaker Studies is multi-disciplinary and inter-disciplinary. It feeds into and from theology, history, philosophy, politics, sociology, anthropology, womens studies, peace studies, literary studies and cultural studies.

The Quaker Studies Research Association, formed in 1992 and with an international membership of around 280, is the umbrella organisation for all those studying, teaching, researching or connected with research into one of the areas of Quaker Studies. It holds an annual conference, hosts the George Richardson Lecture, oversees the David Adshead award for new postgraduates, and publishes a Research Register each year. There is a newsletter and the fully-refereed journal, *Quaker Studies*, twice a year.

Membership includes:

- 1) advance information of all QSRA events and news of related conferences and new publications
- 2) access to the annual QSRA Research Register, listing members and their current areas of interest
- 3) subscription to the journal *Quaker Studies*.

Individual membership rates are £12pa for those with an income of less than £11999pa, £22 for those with an income greater than £12000pa, or US\$20/ \$35. The rate for Quaker Meetings and FAHE Institutions is £22/ \$35.
